Nellis Complex Joint Land Use Study

YOUR INPUT MATTERS! You are invited to the first public open house regarding compatibility planning around Nellis Air Force Base, Creech Air Force Base, and the Nevada Test and Training Range.

Clark County, in cooperation with Lincoln County, Nye County, the City of Las Vegas, the City of North Las Vegas, Nellis Air Force Base (AFB), Creech AFB, the Nevada Test and Training Range (NTTR), and other state and federal agencies and organizations, is preparing the Nellis Complex Joint Land Use Study (JLUS) to promote compatible land use planning around the Nellis Complex and military operating areas. Through this process, stakeholders will identify and review existing and potential compatibility issues from a comprehensive set of 25 compatibility factors, such as communication, land use, noise, vibration, light and glare, and alternative energy.

Moving forward, the community and residents will play a crucial role in the development of the JLUS. Community input provides varying perspectives and differing opinions to ensure that the plan is well rounded and encompassing of community perspectives. In order to effectively gather input, a variety of public engagement opportunities will be provided throughout the process.
